
POLICE OFFICER DAVID VASQUEZ End of Watch: Friday, October 28, 1988

Officer Vasquez was assigned to provide traffic control at a non-injury collision. A civilian driver, later found to be driving on a suspended license, drove into the closed lane and struck Officer Vasquez at approximately 30-40 mph, killing him almost instantly.



POLICE OFFICER JERMAINE GIBSON End of Watch: Saturday, March 19, 2011

Officer Gibson attempted to pull over a stolen vehicle in Cathedral City and a vehicle pursuit ensued. Officer Gibson was tragically killed when his vehicle left the road and crashed into a tree in the city of Palm Springs.

OPERATIONS DIVISION

The Operations Division, the largest division of the Police Department, is comprised of the Patrol Bureau, Traffic Bureau, Homeless Liaison Officer, and Gang Unit. This division is responsible for the following: first police response to emergencies; preliminary and follow-up investigations on property, person, grand theft auto crimes; and basic police patrol services.

In 2018, Patrol Officers handled 58,896 calls. The Police Department is currently staffed with 51 duly sworn Peace Officers, and 32 Professional Staff employees.

INVESTIGATIONS DIVISION

Investigations is comprised of Detectives, Specialized Detectives and Evidence Units, and is responsible for conducting critical incident investigations, follow-up criminal investigations, and preparing cases for prosecution. Detective Bureau investigations include homicides, officer-involved shootings, assaults, armed robberies, sexual assaults, domestic violence, fraud cases, computer crimes, and identity theft. Specialized Detectives conduct investigations of cases involving drugs, vice activities, criminal intelligence gathering to include gangs, and dissemination of intelligence information. Specialized Detectives also aid Federal and State task forces. In 2018, the detectives investigated 235 cases. These cases included two Homicides, 14 Robbery investigations, and 32 Burglaries.



COMMUNICATIONS

The Dispatch Center provides the vital initial contact between the communities of Cathedral City and Desert Hot Springs for Police Services, and the Cathedral City Fire Department. Acting as the Public Safety Answering Point, the Dispatch Center is also responsible for answering all inbound Emergency 9-1-1 calls, including medical aid and fire related calls. Dispatchers must immediately evaluate each call to determine an appropriate police and/or fire response, refer to another division, or transfer to the appropriate agency. Additionally, dispatchers must possess exceptional communication skills, along with the ability to multi-task in a high-stress environment. Several of our dispatchers have received training as "tactical dispatchers" and respond to Crisis Negotiation and SWAT calls, providing key communications support for high-risk operations.

Our Dispatch Center handles the highest call volume in the Coachella Valley, and our fifteen full-time dispatchers answered 189,742 calls in 2018. Those calls resulted in Cathedral City Police Officers being dispatched to 46,730 calls, while 35,436 calls were dispatched to Desert Hot Springs Police Officers, and 5,732 calls were dispatched to Cathedral City Fire services.






CITIZENS ON PATROL

The Cathedral City Police Department has operated a Citizens on Patrol program for over 25 years. Cathedral City COP's currently have 12 active members that participate and contribute in significant ways. COP members assist the department in staffing community and governmental events. They conduct vacation checks on residences and business checks in commercial districts, they assist at crime scenes, traffic collision scenes, and have assisted with weather related emergencies and language translation. They perform weekly neighborhood patrols and notify officers of crime and traffic issues.

The COP crime-prevention value, through their daily patrols, is immeasurable. What can be measured is their contribution of time. The Cathedral City COP members average over 475 hours of volunteer time a month. In 2018, they volunteered over 5,690 hours of service to Cathedral City. They are truly ambassadors for the city and the department, adding a sense of inclusion and well-being to the community.
